Introduction

1. Large number of Welfare Schemes are being run by the HP State Government and Kendriya Sainik Board. Many of these schemes are in the form of financial assistance for educational/vocational purposes. Financial Assistance upto Rs. 10,000/- (Rupees Ten thousand only) is also being provided to economically weaker categories of exservicemen/widows from Armed Forces Flag Day Fund. Non pensioner servicemen/widows, Non pensioner non ECHS members ex-servicemen/widows suffering from serious diseases and orphan dependents of ex-servicemen, who are not in receipt of any pension are proposed to be covered under the financial assistance scheme run by Sainik Welfare Department, Himachal Pradesh. The financial assistance will be a one time grant on case to case basis, which will be paid either from Armed Forces Flag Day Fund or R&R Fund. This scheme will be funded through annual interest accrued on the Corpus of Reconstruction & Rehabilitation Fund and the financial assistance will be given on the basis of funds available with the department.

<u>Aim</u>

2. The aim of this scheme is to assist non-pensioner ex-servicemen, widows and orphan dependents financially.

Objective

 Objective of this scheme is to help non-pensioner ex-servicemen and widows (including those who are suffering from serious diseases) and orphan dependents to tide over financial crisis.

Eligibility Conditions

4. Following categories of ex-servicemen/dependents will be eligible as under :-

(a) Financial Assistance to Non Pensioner Ex-servicemen/Widows

- (i) Applicant should be non-pensioner, i.e., not in receipt of Army/Govt. Pension.
- (ii) Annual income of the applicant should not exceed Rs. 35,000/- per annum or above as amended by HP Govt. from time to time.

(b) Financial Assistance for Serious Diseases

- (i) Non ECHS members & non pensioner ex-servicemen/widows suffering from serious diseases will be eligible for financial assistance.
- (ii) Annual income of the applicant should not exceed Rs. 35,000/- per annum or above as amended by HP Govt. from time to time.
- (iii) Kendriya Sainik Board, New Delhi provides financial assistance subject to a maximum of Rs 1,25,000/- per year and for treatment of cancer/dialysis subject to a maximum of Rs. 75,000/- per annum to non-pensioner ESM of all ranks and widows. Hence, the applicants suffering from serious diseases will be encouraged and assisted in applying for financial assistance from Kendriya Sainik Board.

(c) <u>Financial Assistance to Orphan Dependent Children</u>

(i) Orphan dependent children of ex-servicemen/widows, whose Pension cases are under process will be eligible for one time grant of financial assistance.

Application Form

5. Application should be made on the prescribed application form. Common application specimen application form for financial assistance from R&R Fund and Flag Day Fund is placed as Annexure "1". Applications duly compiled and verified/countersigned by the respective Deputy Directors will be forwarded by ZSWOs to Directorate Office. Copies of the following documents duly checked by the respective ZSWO for correctness will also be forwarded to Directorate Office:-

- (a) Service Documents/Discharge Book of ESM.
- (b) ESM or Widow I-Card issued by respective ZSWO.
- (c) Income certificate issued by competent authority.
- (d) Details of Bank A/c No, Branch Name and IFSC Code.
- (e) Aadhaar Card copy.

Processing of Applications

6. Deputy Director, ZSWOs will ascertain the availability of funds held in Armed Forces Flag Day Fund and prioritize/decide the payment either from Flag Day Fund or R&R Fund. Recommended applications alongwith documents and complete detail either from R&R Fund or Flag Day Fund will be forwarded separately as per Annexure "2" to Directorate Sainik Welfare on monthly basis on an Excel Sheet duly signed by board constituted at ZSWO alongwith a soft copy in CD.

Payment Procedure

7. Directorate Sainik Welfare will compile the applications received from all ZSWOs on monthly basis separately for R&R Fund and Flag Day Fund and detail a board of officers/officials for scrutiny. After approval, the payment will be made directly to the beneficiaries' accounts via Electronic Clearing System (ECS) from R&R Fund whereas sanction will be accorded to ZSWOs to disburse the amount from Flag Day Fund. Applications received from ZSWOs will be returned to concerned ZSWOs duly recommended/rejected.

Conclusion

8. This financial assistance is a welfare measure being extended to the non-pensioner ESM, Widows and orphan dependent. The financial assistance will be given only for eligible and financially weaker categories. Number of grant of financial assistance will depend upon the availability of funds under relevant schemes.
