- (c) Candidate should be in possession of original discharge book and valid arms licence (for armed guard only) with self attested photocopies of both the documents.
- (d) Age should be below 55 years as on 01 Jan 2025.
- (e) A candidate who has registered their names before the date of screening will only be permitted to attend the screening process.
- (f) Ex-servicemen will be screened as per above schedule for placement against vacancies occurring w.e.f. 01.01.2025 to 31.12.2025.
- (g) Current panel of ex-servicemen uploaded on this Corporation website would be valid till 31.12.2024 and stand superseded w.e.f. 01.01.2025.
- (h) Screening of ex-servicemen would be conducted as per above mentioned schedule for placement on temporary basis till availability of work.
- (j) Average yearly placement of ESM as Security Guards during the last 3 years is approximately 275 ESMs.

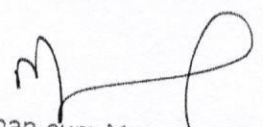

- (f) JCOs will be screened as per above schedule for placement against vacancies occurring w.e.f. 01 Jan 2025 to 31 Dec 2025.
- (g) Current panel of JCOs uploaded on this Corporation website would be valid till 31 Dec 2024 and stand superseded w.e.f. 01 Jan 2025.
- (h) Screening of ex-servicemen would be conducted as per above mentioned schedule for placement on temporary basis till availability of work.
- (j) Average yearly placement of ESM as Security Supervisor during the last 3 years is approximately 12 JCOs.
