SCHEDULE FOR SCREENING OF EX-SERVICEMEN FOR ENGAGEMENT ON OUTSOURCED BASIS AS SECURITY GUARDS, ARMED GUARDS, FIREMEN, DRIVER-CUM-PUMP OPERATORS AND DRIVERS AT VARIOUS PROJECTS/LOCATIONS IN HIMACHAL PRADESH


1. The Himachal Pradesh Ex-servicemen Corporation, Hamirpur invites eligible Ex-servicemen (ORs only) belonging to all districts of Himachal Pradesh to appear for screening for engagement on outsourced basis at various projects/locations in Himachal Pradesh as per the details given below:-

2. **Eligibility Criteria.** Eligible Ex-servicemen fulfilling the following conditions may appear for screening:-

- (a) Ex-servicemen up to the rank of Havildar and Hony Nb Sub only.
- (b) Age should be as specified against each category and shall be reckoned as on 01 July 2026.
- (c) Candidates applying for Armed Guard category must possess a valid Arms Licence.
- (d) Candidates applying for Driver category must possess a valid Heavy Motor Vehicle (HMV) Driving Licence issued by the competent Civil Authority.
- (e) Only those Ex-servicemen who have registered their names with HIMPESCO prior to the date of screening shall be permitted to participate.
- (f) Minimum educational qualification shall be Matriculation from a recognized Board/Institution.
- (g) Character grading in the Service Records must be **Excellent or Very Good**.
- (h) Medical category should not be below **S1H1A1P2E2**. Ex-servicemen discharged on psychiatric grounds or placed in low medical category due to psychiatric reasons shall not be considered.
- (j) Ex-servicemen discharged from service on disciplinary grounds shall not be considered.

3. **Reporting Time.** Screening will commence at **1030 hrs on 19 June 2026**. All eligible candidates are required to report at the venue by **1000 hrs** positively.
4. **Documents Required.** Candidates must bring the following original documents along with self-attested photocopies wherever applicable:-
- Original discharge book with self attested photocopy.
 - Bonafide Himachali certificate issued by the respective Tehsildar.
 - Character certificate from respective Tehsildar.
 - Adhaar Card, PAN Card and Bank Account Number.
 - Civil Educational Certificates and Diploma certificates.
 - Four recent passport size photographs.
5. **Terms And Conditions.**
- No TA/DA shall be admissible for attending the screening.
 - No accommodation, food or uniform shall be provided by HIMPESCO during deployment. However, HRA and Uniform Allowance shall be admissible as per approved norms and terms of deployment.
 - Participation in the screening process does not confer any right for employment.
 - The screening is only for preparation/updation of the waiting panel. Actual deployment shall be made strictly as per availability of vacancies, project requirements and approved waiting panel.
 - The decision of HIMPESCO regarding screening, empanelment and deployment shall be final and binding.
